 - ◆ **Please note that if all information is not provided your licence can not be processed.**
- To obtain an International Licence, a cyclist must be a member of Cycling Australia. Applications must be submitted on this form to Cycling Australia **one month** prior to departure. **If the application is received 2 weeks or less from departure then a late fee will be payable.**

Declaration:

1. I hereby declare that I am aware of no reason why I should not be issued with the licence requested. I undertake to return my licence as soon as new element occurs modifying substantially the circumstances existing at the time of the licence application. I declare that I have not applied for a licence for the same year to the UCI or to any other National Federation. I assume exclusive liability for the application and for the use that I shall make of the licence.
2. I hereby undertake to respect the Constitution and Regulations of the International Cycling Union, its Continental Confederations, and its National Federations. I declare having read or having had the opportunity to read such Constitution and Regulations. I shall participate in cycling competitions or events in a fair and sporting manner. I shall submit to disciplinary measures taken against me and shall take any appeals and litigation before the authorities provided for in the Regulations. I accept the Court of Arbitration for Sport (CAS) as the only competent jurisdiction of appeal in the cases provided for by the Regulations and in compliance with the terms thereof. I accept that the decisions of CAS shall be final and binding and not subject to appeal. With that reservation, I shall submit any litigation with the UCI exclusively to the tribunals at UCI headquarters.
3. I accept to comply with and to be bound by the UCI Anti-Doping Regulations, the World Anti-Doping Code and its international standards to which the UCI Anti-Doping Regulations refer as well as the anti-doping regulations of other competent instances as foreseen by the UCI Regulations and the World Anti-Doping Code, provided such regulations comply with the World Anti-Doping Code. I agree that the results of the analysis may be made public and communicated in detail to my club, team or trade team or to my coach or doctor. I agree that all urine samples taken shall become the property of the UCI which may have them analysed, especially for the purposes of health protection research and information. I agree that my doctor or the doctor of my club, Trade Team may, on a request from the UCI, communicate to it a list of any medicines I took and treatment I underwent before any given competition.
4. I accept the conditions regarding blood testing and accept to undergo blood tests.

NOTE CLAUSES 5 & 6 APPLY TO ELITE and U23 CATEGORIES ONLY
NOTE CLAUSE 6 APPLIES TO MASTERS AT WORLD CHAMPIONSHIPS

5. I accept that I am responsible for the provision of accurate whereabouts information to the relevant authorities in accordance with the World Anti-Doping Code and that I must keep this information updated at all times. I am aware that if I am included on a Registered Testing Pool established by the UCI or ASADA I will be responsible for providing such accurate and updated whereabouts information to the respective authority.
6. I accept that if I have a documented medical condition regarding the use of a prohibited substance or a prohibited method I must first obtain a Therapeutic Use Exemption (TUE) in accordance with the World Anti-Doping Authority International TUE Standard. If I require a TUE I acknowledge that a properly completed TUE application shall be submitted to the UCI at least 21 days prior to my participation in any International event. Furthermore I acknowledge that I do not have permission to participate in any UCI International event until I have received the Certificate of Approval for Therapeutic Use from the UCI Therapeutic Use Exemption committee.
